 - b. **The price bid envelope** must consist of all the charges inclusive of travel expenses, fooding/ lodging local travelling expenses for carrying out the above job. The price must be quoted in the Prescribed PRICE BID Format attached herewith. The service tax, GST if any, applicable may also be indicated separately.
6. The successful valuer is required to visit BVFCL Namrup Assam for carrying out the Inspection Job as per intimation received from BVFCL. Tentatively there will be 04 (Four) Nos. of visits on quarterly basis depending upon the generation of scrap.
